○ Transportation

JI Wenhua
Professor of School of Law, University of International Business and Economics
(UIBE)

Dr. JI Wenhua is a Professor at the School of Law, University of International Business and Economics (UIBE) in Beijing, China. His research encompasses international economic law, international commercial transactions, dispute resolution, and global economic governance. He has published extensively on these topics in both Chinese and English. Dr. Ji holds several prestigious positions, including Co-Chair of the WTO Chairs Programme at UIBE, UNIDROIT Correspondent for China, and Standing Council Member of the WTO Law Research Society of the Chinese Law Society. Additionally, he has actively participated in the legislative processes for various trade and investment laws in China.



Anna Joubin-Bret Secretary, United Nations Commission On International Trade Law (UNCITRAL)

Ms. Anna Joubin-Bret is the Secretary of the United Nations Commission On International Trade Law (UNCITRAL) and the Director of the International Trade Law Division in the Office of Legal Affairs of the United Nations, which functions as the substantive secretariat for UNCITRAL. She is the ninth Secretary of the Commission since it was established by the General Assembly in 1966.

Prior to her appointment on 24 November 2017, Ms. Joubin-Bret practiced law in Paris, specializing in International Investment Law and Investment Dispute Resolution. She focused on serving as counsel, arbitrator, mediator and conciliator in international investment disputes. She served as arbitrator in several ICSID, UNCITRAL and ICC disputes. Prior to 2011 and for 15 years, Ms. Joubin-Bret was the Senior Legal Adviser for the United Nations Conference on Trade and Development (UNCTAD). She edited and authored seminal research and publications on international investment law, notably the Sequels to UNCTAD IIA Series and co-edited with Jean Kalicki a book on Reform of Investor-State Dispute Settlement in 2015.

Ms. Joubin-Bret holds a post-graduate degree (DEA) in Private International Law from the University of Paris I, Panthéon-Sorbonne, a Masters Degree in International Economic Law from University Paris I and in Political Science from Institut d'Etudes Politiques. She was a Legal Counsel in the legal department of the Schneider Group, General Counsel of the KIS Group and Director-Export of Pomagalski S.A. She was appointed judge at the Commercial Court in Grenoble (France) and was elected Regional Counsellor of the Rhône-Alpes Region in 1998.



Michael Imran Kanu Ambassador and Permanent Representative of Sierra Leone to the United Nations

Dr. Michael Imran Kanu is an Ambassador and Permanent Representative of Sierra Leone to the United Nations. He also holds concurrent appointments as an Ambassador of Sierra Leone to Argentina, Cuba, Mexico, Uruguay, and Venezuela, as well as a Permanent Representative to the International Seabed Authority (ISA). In August 2024, He presided as President of the UN Security Council, and currently chairs the Council's Sanctions Committees concerning the DRC and South Sudan and leads its Informal Working Group on Criminal Tribunals. He is a member of the Legal and Technical Commission of the ISA and Vice-President of the International Criminal Court Assembly of States Parties, where he co-chairs its Review Mechanism. He previously served as an Ambassador and Deputy Permanent Representative for Legal Affairs of Sierra Leone to the UN from 2018 to 2023., in which role he served as Coordinator of the African Group's Legal Experts on UNCITRAL Working Group III regarding ISDS reform. He holds an SJD and LL.M in International Business Law from Central European University, B.L. from Sierra Leone Law School, and LL.B from Fourah Bay College, University of Sierra Leone. He is an UN International Law Fellow and a Visiting Senior Fellow at the London School of Economics and Political Science.



Peter van den Bossche Former Director of Studies, World Trade Institute (WTI)

Peter Van den Bossche is a former Member and Chair of the Appellate Body of the World Trade Organization (2009-2019), a former Director of Studies of the World Trade Institute (2016-2024), and Professor of International Economic Law at the University of Bern. Since 2018, he is the President of the Society of International Economic Law (SIEL). Van den Bossche is also a professor emeritus at Maastricht University and a visiting professor at Bocconi University, Milan (since 2023), the Université de Genève (since 2018), LUISS Guido Carli University, Rome, Italy (since 2016), the Universidad San Francisco de Quito, Ecuador (since 2016), and the College of Europe, Bruges (since 2010). Van den Bossche is the author (with Werner Zdouc) of The Law and Policy of the World Trade Organization, 5th edition (Cambridge University Press, 2021), 1170 p., and (with Denise Prévost) of Essentials of WTO Law, 2nd edition (Cambridge University Press, 2021), 223 p. The Chinese edition (with SHAN Wenhua) of The Law and Policy of the World Trade Organization was published in 2020 by Law Press China.



Teresa CHENGFounding Member, Asian Academy of International Law(AAIL)

Teresa Cheng SC, GBM, GBS, JP is a Senior Counsel, Chartered Engineer, Chartered Arbitrator, and Mediator with a distinguished record of public service in the Hong Kong Special Administrative Region (SAR). From January 2018 to June 2022, Ms Cheng was the Secretary for Justice of the Hong Kong SAR.

She is one of the founding members of the Asian Academy of International Law, a past Vice President of the International Council for Commercial Arbitration, a past Vice President of the ICC International Court of Arbitration, and a past Chairperson of the HKIAC. In 2008, she became the first Asian woman elected through a global election as President of the Chartered Institute of Arbitrators. She served as Deputy Judge/Recorder in the High Court of Hong Kong from 2011 to 2017 and was also a member of the World Bank's Sanctions Board.

Ms. Cheng is a Fellow of King's College London. She serves on the Expert Committee of the China International Commercial Court and the Expert Committee for the Establishment of International Commercial Arbitration Centers, appointed by the Ministry of Justice of PRC. She is currently an adjunct professor, the founder and co-director of the International Arbitration and Dispute Settlement Course at Tsinghua University.

LIANG Danni is an associate professor of School of Law, Sun Yat-Sen University. She earned her PhD degree in international law from Wuhan University in 2006 and also obtained a Master of Law (2002) and an LL.B (1999) degrees from Sun Yat-Sen University. She was a visiting scholar in Vermont School of Law in 2008. From 2012 to 2014, she has been a member of delegation group of Chinese government to take part in the consultation of UNCITRAL Transparency Rules and Mauritius Transparency Convention, and the negotiation of the China-US BIT also. From 2020, she has been a member of delegation group of Chinese government to take part in the sessions of UNCITRAL Working Group III (Investor-State Dispute Settlement Reform). In September 2024, She has been the delegate of CIETAC to participate the 49th session of UNCITRAL WG III.



Chin Heng ONGSenior Director / Senior State Counsel of International Affairs Division, Attorney-General's Chambers, Singapore

Ong Chin Heng is Senior State Counsel/Senior Director (International Affairs), leading the International Economic Law practice at the Attorney-General's Chambers of Singapore.

His experiences include negotiating Singapore's free trade agreements with the European Union, China, the Eurasian Economic Union, ASEAN, and the Trans-Pacific Partnership (now CPTPP), as well as international investment treaties with various countries.

He has led Singapore's delegation at the International Centre for Settlement of Investment Disputes (ICSID) and the UN Commission on International Trade Law (UNCITRAL) on reforms to investor-State dispute settlement and investment arbitration rules. He acted as counsel in Singapore's interventions before the World Trade Organization for disputes concerning IT Products, and US tariffs against Chinese goods, and before a CPTPP panel in a dispute concerning dairy measures.

Besides economic law, Chin also served as counsel in the case before the International Court of Justice concerning sovereignty over Pedra Branca, and represented Singapore in international aviation, law of the sea, arms control, counter-proliferation and counter-terrorism matters.

Chin is an alumnus of the National University of Singapore and New York University, and is called to the Bars in Singapore and New York. He was awarded the Public Administration (Bronze) Medal in 2008 and Long Service Medal in 2022.

After returning from Geneva, Prof.Chang also served for the Korean government as the Chairman of the Korea Trade Commission. In 2022, he was appointed, for the first time in history, as an appellate review arbitrator for WTO dispute settlement.

Prof.Chang practiced at Covington & Burling in Washington D.C., and served as a judge for Seoul District Court in his early legal career.

Prof. Chang holds law degrees from SNU (LL.B.) and Harvard Law School (LL.M. & S.J.D.). He has taught international arbitration, investment and trade law courses as a tenured professor at SNU and, as a Visiting Professor, at various renowned law schools including Harvard, Yale, Stanford, NYU, Duke, Georgetown, UCLA, National University of Singapore, Hong Kong University, and Geneva University. In 2007, Harvard Law School granted him an endowed visiting professorial chair title, Nomura Visiting Professor of International Financial Systems.

Prof.Chang is also Editor-in-Chief for Korean Arbitration Review, and an Advisory Board Member for the Journal of International Dispute Settlement (Oxford) and formerly the Journal of International Economic Law (Oxford).

Sichuan Opera, Shu Embroidery, and many other intangible cultural heritage items have been passed on for thousands of years.

Intangible Cultural Heritages

Chengdu's history of more than 4,500 years has given birth to rich and diverse ethnic cultures and folk cultures, providing a breeding ground and cultural nutrients for the thriving intangible cultural heritages. To date, Chengdu has 1 world-class intangible cultural heritage item, 25 national intangible cultural heritage items, and 86 provincial intangible cultural heritage items.

O Sichuan Cruisine

Sichuan cruisine, one of the four major Chinese culinary traditions, is renowned for its distinctive spicy and numbing flavor, as well as its diverse cooking techniques. The ingredients primarily consist of mountain delicacies, seafood, fruits, and vegetables from the Sichuan region. Common seasonings include Sichuan sugar, Sichuan pepper and chili, as well as thick broad-bean sauce and fermented bean curd. Sichuan cruisine encompasses 40 cooking techniques, including quick-frying, sauting, drizzling with oil, deep-frying, etc. The standout flavors of Sichuan cruisine are numbing spiciness (mala), fish-fragrant flavor (yuxiang), and exotic flavor (guaiwei).

Chengdu Research Base of Giant Panda Breeding

The Chengdu Research Base of Giant Panda Breeding is a world-renowned ex-situ conservation, research and breeding, science education, and cultural tourism base for giant pandas. Covering an area of 3.07 square kilometers, it is one of the most anticipated attractions for tourists worldwide, attracting 9 million visitors annually.

Jinsha Site Museum

Jinsha Site Museum in Chengdu is dedicated to the protection, research, and display of Jinsha culture and ancient Shu civilization. It is a national first-class museum and has been selected as one of China's first national archaeological site parks. The museum houses 2,235 pieces (sets) of cultural relics, such as gold, including 366 pieces (sets) of first grade cultural relics.



Dujiangyan Irrigation System

Built about 2,250 years ago, Dujiangyan Irrigation System is a part of the Mount Qingcheng and Dujiangyan Irrigation System, a world cultural heritage and natural heritage site. It is the world's only surviving water diversion project without a dam and also a world irrigation engineering heritage site.

Anshun Bridge

The Anshun Bridge, located next to the Hejiang Pavilion at the confluence of the Fuhe River and the Nanhe River in Chengdu, has a long history dating back to the Yuan Dynasty. In Marco Polo's travelogue, the Anshun Bridge is one of the four bridges that left a deep impression on him.
