

UNCITRAL ASIA PACIFIC DAYS REPORT 2023

Introduction

1. This report on the UNCITRAL Asia Pacific Days ('AP Days') highlights the objectives of this flagship activity series, the deliverables produced, and the outcomes achieved. An introduction of the UNCITRAL AP Days and an illustrated summary of the salient features of the 2023 series are first provided, followed by concluding remarks. Highlights from each activity appear in <u>Annex I</u> and testimonials from partnering institutions and participants appear in <u>Annex II</u>.

AP Days 2023: a snapshot

A brief overview

2. The AP Days are an annual flagship academic series launched in 2014 by the United Nations Commission on International Trade Law Regional Centre for Asia and the Pacific ('UNCITRAL' or the 'Commission', and 'UNCITRAL RCAP') to commemorate United Nations General Assembly resolution 2205 (XXI) of 17 December 1966 establishing UNCITRAL, which has since come to be the core legal body of the United Nations system in the field of international trade law.

3. Since the first edition of the AP Days in 2014, universities and institutions across the Asia-Pacific region have joined the annual celebration by co-hosting a series of academic events with UNCITRAL RCAP to promote awareness of international trade standards and norms, particularly those endorsed by UNCITRAL, amongst law students — the next generation of legal thinkers and policymakers. These events are academic in nature and are free of admission charges. In some instances, the deliverables have served to provide capacity building to public and private stakeholders and assist participating jurisdictions in their consideration of adopting UNCITRAL texts.

4. The success of the AP Days has led to the expansion of "UNCITRAL Days" to other regions, including the UNCITRAL Latin American and Caribbean Days, the UNCITRAL Days in Africa and the UNCITRAL Days for the Arab States (on a pilot basis in 2023). The Commission has noted with interest the further expansion of engagement with academic partners, geared towards young researchers and practitioners in international trade law through UNCITRAL Days in various regions.¹

5. It should be noted that whereas the reporting period of the previous editions of the AP Days report was from 1 April to 31 March (of the following year), the reporting period of the 2023 series has been changed to 1 April to 31 December 2023. Going forward, the reporting period of the AP Days will be on a calendar year basis. Reports of previous AP Days are available on the UNCITRAL website.²

AP Days 2023

6. The AP Days 2023 series is the tenth edition of this UNCITRAL RCAP flagship with events taking place from May to December 2023. The series was successfully organized with the generous support and collaboration of institutional and academic partners throughout the region. Each AP Days activity had its own unique and diverse features in terms of deliverables, topics covered, audience reached, and mode of delivery. Highlights of each AP Days activity listed in chronological order can be found in **Annex I**.



Theme and main subject areas

7. The theme for AP Days 2023 was "Exploring the digital frontiers of crossborder trade", and provided a timely opportunity to raise awareness among students and other stakeholders on how UNCITRAL's e-commerce instruments, project on stocktaking of developments in dispute resolution in the digital economy (DRDE), and ongoing legislative work on automation in contracting, including artificial intelligence, and on data contracts could support States in developing an enabling legal framework for cross-border trade in the digital economy. UNCITRAL RCAP also welcomed partnering institutions' joint development of other themes in accordance with their interests.

8. In addition to the digital economy, other subject areas explored in the AP Days 2023 series included, in diminishing order of frequency, international commercial arbitration and mediation, international sales of goods, micro, small and medium-sized enterprises ('MSMEs') and access to credit, and cross-border insolvency. Most AP Days events began with an introduction to UNCITRAL and UNCITRAL RCAP including the online courses and the internship programme.³





Level of participation


9. The AP Days 2023 series spanned a total of 17 events across 11 jurisdictions in the Asia-Pacific region, which observed an increase in both the numbers of events and co-hosting jurisdictions from the 2022 series despite a shorter reporting period.


10. As shown in the graphs below, since the launch of the AP Days in 2014, there has been an upward trend in both the numbers of events and co-hosting jurisdictions, most notably in the three-year period since 2020 following the introduction of virtual or hybrid modes of participation.






2023 UNCITRAL ASIA Pacif 11. Turning to a year-on-year comparison, the number of partnering institutions increased from 28 in the 2022 series to 32 in the 2023 series. Following the lifting of COVID-19 restrictions in the Asia-Pacific region, some partnering institutions preferred in-person attendance by participants (while still accommodating virtual participation by speakers), leading to a decline in the cumulative size of the audience in the 2023 series, although the overall outreach continues to be greater than the pre-pandemic period, with online participants joining from the Asia-Pacific region and beyond as detailed in paragraph 13 below.





Co-hosting jurisdictions

12. The 11 jurisdictions which co-hosted the AP Days 2023 series were: China (including Hong Kong and Macao), India, Indonesia, Japan, Maldives, Philippines, Republic of Korea, Russian Federation and Sri Lanka; among these Indonesia was a new jurisdiction hosting its inaugural AP Days event.




Number of Events per Jurisdiction

Participation, audience diversity and gender parity

13. Audience composition continued to be diverse. While AP Days events are geared towards law students and the academic community in the region, the AP Days 2023 events reached a global audience from co-hosting jurisdictions and beyond, totalling 43 jurisdictions as shown in the map below, among which 11 were least developed countries, landlocked developing countries and small island developing states (Afghanistan, Bangladesh, Cambodia, Lao People's Democratic Republic, Maldives, Mongolia, Myanmar, Nepal, Rwanda, Tanzania and Uzbekistan).




14. The composition of speakers was similarly diverse. In addition to experts from co-hosting jurisdictions, the AP Days 2023 series engaged speakers based in Australia, Austria, Italy, Portugal, Sweden, Switzerland and Thailand, adding international perspectives to the discussions.

15. Based on available information from the co-organizers, gender parity is demonstrated in participants and speakers, with more than half of the participants (57%) and speakers (58%) being women.




Regional accessibility, multilingualism, deliverables and formats

16. As with previous editions, the format of the AP Days 2023 events ranged from closed in-class lectures to full-day public international conferences. The events adopted mostly a hybrid format, with UNCITRAL RCAP staff joining remotely while students joined in-person, or a virtual format. Fully in-person mode also resumed in this series.



17. UNCITRAL RCAP officers supported all of the AP Days events, with colleagues from UNCITRAL headquarters in Vienna, including the Secretary of UNCITRAL, joining some events to deliver technical presentations on topics such as the United Nations Convention on the International Effects of Judicial Sales of Ships ('Beijing Convention on the Judicial Sale of Ships'), the United Nations Convention on Contracts for the International Sale of Goods ('CISG') and DRDE project. Most contributions continued to take the form of live remote presentations. Where live presentations were not possible, UNCITRAL RCAP provided tailor-made video remarks or institutional support.

18. To enhance regional accessibility and multilingualism, UNCITRAL RCAP officers and participating experts delivered presentations in multiple United Nations official languages, particularly Chinese and English, as well as regional languages including Korean. More than one language was used in three events.



21. In light of the comprehensive theme and topics explored during the AP Days 2023 series on how UNCITRAL's work on legal harmonization facilitates international trade and investment, inclusive participation by experts and audiences from diverse jurisdictions and backgrounds, focus on educating the next generation, expanded modes of delivery, and deliverables in multiple United Nations and regional languages, the AP Days 2023 events have, like previous editions, supported UNCITRAL's contributions towards achieving the Sustainable Development Goals ('SDGs') on several fronts, including:⁴





UNCITRAL online courses

23. UNCITRAL's online courses were also introduced as a key feature in the AP Days events. In collaboration with the International Training Centre of the International Labour Organization (ITCILO), UNCITRAL has launched four courses so far, namely, "Introduction to the United Nations Commission on International Trade Law," "UNCITRAL Texts on Public Procurement and Public-Private Partnerships," "UNCITRAL Mediation Framework" and "UNCITRAL International Commercial Arbitration."

24. These interactive and self-paced courses introduce users to UNCITRAL's work on legal harmonization in promoting international trade and its contribution to the achievement of the SDGs. They further provide an overview of UNCITRAL texts on public procurement and public-private partnerships and the UNCITRAL mediation and arbitration frameworks.

25. The four courses are currently available in both Chinese and English, with translation into additional United Nations official languages as resources allow. All online courses are free of charge and an electronic certificate is downloadable from the platform for users upon completion.

UNCITRAL RCAP Internship

27. Another theme highlighted throughout the AP Days 2023 series was the UNCITRAL RCAP Internship Programme. Anchored from the UNCITRAL RCAP office in Incheon, Republic of Korea, interns improve their knowledge of international trade law principles by gaining first-hand experience about the work of UNCITRAL, activities of the UNICTRAL secretariat and the principal areas in which UNCITRAL operates, including technical assistance to trade law reform, and broad exposure to the activities of an international organization. UNCITRAL RCAP interns work under the direct supervision of UNCITRAL RCAP professional staff and the positions are for a duration of two to six months. The internship may be undertaken remotely, in-person or in hybrid mode at the UNCITRAL RCAP office.⁵

Concluding remarks

28. As expressed by a partnering institution, the AP Days offer "students and young practitioners the unique opportunity to look beyond their own horizons, as they are able to get an insight into the work of one of the most important institutions in the world." Through the AP Days, it is hoped that more students, academics, legal practitioners, policy makers and other stakeholders acquire deeper understanding of how legal harmonization facilitates international trade and investment, and the key role of UNCITRAL instruments and their uniform interpretation. It is also hoped that coorganizing institutions continue to utilize technology to enhance the accessibility and outreach of the AP Days, engaging participants and speakers from diverse backgrounds and geographical locations.

The Centre for Transnational Commercial Law at National Law University Delhi; Insolvency and Bankruptcy Board of India; INSOL India; and Insolvency Law Academy (New Delhi, 6 May 2023)

The AP Days event was held as part of the valedictory session of the 6th Arun Jaitley International Insolvency and Bankruptcy Moot Competition on 6 May 2023 in New Delhi, India. It was co-organized with the Centre for Transnational Commercial Law at National Law University Delhi and supported by the Insolvency and Bankruptcy Board of India, INSOL India, and the Insolvency Law Academy, and attended by around 32 participants.

The competition is the first International Moot in India focusing on insolvency after India's enactment of the Insolvency and Bankruptcy Code 2016. Held with the support of UNCITRAL RCAP since its inception, this year's moot, themed "Corporate Insolvency including Cross-Border Insolvency," aimed to incorporate the UNCITRAL Model Laws on Enterprise Group Insolvency and on Cross-Border Insolvency in India's Insolvency and Bankruptcy Code. The Head of UNCITRAL RCAP delivered a special address on the importance of international collaboration in the field of cross-border insolvency.



Transnational Business Law Department, Faculty of Law, Padjadjaran University (Bandung, Indonesia, 11 May 2023)

On 11 May 2023, UNCITRAL RCAP co-organized the AP Days event with the Transnational Business Law Department, Faculty of Law of the Padjadjaran University with the theme "Recent Developments of UNCITRAL Instrument in Arbitration and Mediation." The virtual event attracted 211 participants (136 women and 75 men).




Hanyang University School of Law (Seoul, 18 September 2023)





Jungseok Research Institute of International Logistics and Trade, Inha University (Seoul, 21 September 2023)

On 21 September 2023, UNCITRAL RCAP co-organized its 3rd AP Days event with Jungseok Research Institute of International Logistics and Trade, Inha University. Themed "Exploring the digital frontiers of cross-border trade", the virtual event hosted 23 participants (17 women and 6 men) from four different departments.

Jungseok Research Institute of International Logistics and Trade highlighted the importance of collaboration between UNCITRAL RCAP and Inha University, especially in the field of digital trade and e-commerce. UNCITRAL RCAP then delivered presentations introducing the work of UNCITRAL RCAP and UNCITRAL texts on e-commerce, followed by a presentation from Inha University focusing on different e-commerce platforms and latest developments. The event ended with an introduction to the UNCITRAL internship programme, during which an UNCITRAL RCAP intern shared his experiences.



Software-Information Asset Protection Talent Development Division, Chung-Ang University (Seoul, 10 October 2023)

On 10 October 2023, UNCITRAL RCAP co-organized the AP Days event with Software-Information Asset Protection Talent Development Division of Chung-Ang University. The event was held in Korean in an in-person format with 25 participants (10 women and 15 men) ranging from students to experts from public and private sectors.

The Security Research Center at Chung-Ang University highlighted the importance of addressing challenges while also pursuing Sustainable Development Goals (SDGs) in the use of transferable documents in electronic form, in the face of the increasing impact of digital technologies. UNCITRAL RCAP then introduced the UNCITRAL e-commerce texts which enable and facilitate the use of electronic means to engage in commercial activities. The importance of legal harmonization through UNCITRAL texts was emphasized to address the challenges and obstacles in digital trade, supporting States in developing an enabling legal framework for cross-border trade in the digital economy.



Faculty of Law, The Chinese University of Hong Kong (Hong Kong, China, 7 November 2023)

On 7 November 2023, UNCITRAL RCAP co-organized the inaugural AP Days event with the Faculty of Law of the Chinese University of Hong Kong. The event was held in a hybrid format with 176 participants.

The Chinese University of Hong Kong highlighted the importance of UNCITRAL legal framework in response to the increasing impact of digital technology and artificial intelligence in trade and investment. The Secretary of UNCITRAL delivered an inperson presentation on UNCITRAL latest developments including the Beijing Convention on the Judicial Sale of Ships, the Taxonomy of legal issues related to the digital economy, the DRDE project, and an overview of UNCITRAL texts on ecommerce. UNCITRAL RCAP also introduced the internship programme and UNCITRAL online courses. Following UNCITRAL presentations the university hosted a panel discussion on the transformative role of technology in cross-border trade and investment.



Office for Alternative Dispute Resolution, Department of Justice, Philippines (Manila, 13 November 2023)

On 13 November 2023, UNCITRAL RCAP and the Office for Alternative Dispute Resolution, Department of Justice of the Philippines co-organized an AP Days event, which formed part of the ADR Roadshow in the National Capital Region for Schools. The event was held in a hybrid format with 126 participants (65 women, 58 men and 3 undisclosed). The audience comprised both law students and students without a legal background from private and public schools.

The event featured various discussions and experiential activities relating to alternative dispute resolution. The Head of UNCITRAL RCAP provided a presentation introducing UNCITRAL works, texts and legal frameworks, focusing on e-commerce, the CISG and the Case Law on UNCITRAL Texts (CLOUT) database. Legal experts from UNCITRAL RCAP then presented on the UNCITRAL arbitration framework (including the transparency standards), the UNCITRAL mediation framework and the UNCITRAL RCAP internship programme.



Faculty of Law, The University of Hong Kong; Hong Kong Mediation Centre; and International Dispute Resolution & Risk Management Institute (Hong Kong, China, 15 November 2023)

On 15 November 2023, UNCITRAL RCAP co-organized the AP Days event with the Faculty of Law of the University of Hong Kong, Hong Kong Mediation Centre, and International Dispute Resolution & Risk Management Institute themed "Unleashing the Potential of Cross-border Digital Trade". The event was held in a hybrid format with 55 participants (31 women and 24 men).



On 18 November 2023, UNCITRAL RCAP co-organized the AP Days event with Peking University School of Transnational Law and the Rede Chambers. The event was held in a hybrid format with 10 participants (8 women and 2 men).

Themed "An examination of some recent Hong Kong court decisions and fireside chat discussion," the event discussed topical issues on international commercial arbitration and Hong Kong arbitration cases highlighting the court's pro-arbitration approach. The Head of UNCITRAL RCAP introduced the work of UNCITRAL and its arbitration framework (including the transparency standards) and an UNCITRAL RCAP legal expert gave a presentation on UNCITRAL mediation texts and internship programme.



Faculty of Law, University of Macau; World Trade Center Macau Arbitration Center; Shanghai Arbitration Commission; and CIETAC Hong Kong Arbitration Center (Macao, China, 1 & 12 December 2023)

On 1 December 2023, UNCITRAL RCAP co-organized the 10th Anniversary UNCITRAL RCAP – UM Joint Conference 2023 with the Faculty of Law of the University of Macau, supported by World Trade Center Macau Arbitration Center, Shanghai Arbitration Commission and CIETAC Hong Kong Arbitration Center. The joint conference was held in hybrid mode with 231 participants.

Themed "National and Regional Harmonisation of International Trade Law: A Decade in Retrospect and the Desiderata of the Future," the joint conference discussed harmonization of international trade law and its national and regional manifestations across the Greater Bay Area of China, with a focus on micro, small and medium-sized enterprises (MSMEs), e-commerce, cross-border insolvency and dispute resolution. UNCITRAL RCAP provided presentations on the latest developments of UNCITRAL's work, the UNCITRAL arbitration (including transparency standards) and mediation frameworks, and the UNCITRAL Guide on Access to Credits for MSMEs. An UNCITRAL legal officer also presented on the DRDE project.

As part of the AP Days event, on 12 December 2023, UNCITRAL RCAP provided a dedicated session on the RCAP internship programme to the law students at the University of Macau, with experience sharing by UNCITRAL RCAP interns.



The Maldives National University; Faculty of Shariah and Law, Villa College; and Maldives Moot Court Society (Malé, 14 December 2023)

On 14 December 2023, UNCITRAL RCAP co-organized the AP Days event with Maldives National University, Faculty of Shariah and Law of Villa College and the Maldives Moot Court Society. The event was held in a virtual format hosting 100 participants (48 women, 50 men and 2 undisclosed), including students and experts from the field of cross-border commercial dispute resolution.

Villa College provided opening remarks highlighting the important role of UNCITRAL in promoting the progressive harmonization and development of international trade law. UNCITRAL RCAP presented the DRDE project, the Taxonomy of legal issues related to the digital economy, the UNCITRAL mediation framework, and the internship programme. An UNCITRAL RCAP intern also shared his first-hand experience. Other speakers discussed the status of mediation in the Asia-Pacific region including the human element in the mediation process.



School of Law, Far Eastern Federal University (Vladivostok, Russian Federation, 20 December 2023)

On 20 December 2023, UNCITRAL RCAP co-organized the AP Days event with the School of Law of Far Eastern Federal University. The event was held in a hybrid format hosting 47 students (30 women and 17 men).

The Head of UNCITRAL RCAP provided a presentation on the latest UNCITRAL developments including the Beijing Convention on the Judicial Sale of Ships, the Taxonomy of legal issues related to the digital economy and the DRDE project. UNCITRAL RCAP legal experts then delivered two presentations on the UNCITRAL arbitration and mediation frameworks, and the UNCITRAL Guide on Access to Credit for MSMEs. Other speakers discussed the status and perspectives of international commercial arbitration and digital legal regulation in Russia. UNCITRAL interns also shared their experiences.




Nagoya University Graduate School of Law; and Asian Institute of International Financial Law, The University of Hong Kong (Nagoya, Japan, 20 December 2023)
