Jointly organised by the Singapore Ministry of Law (MinLaw) and the United Nations Commission on International Trade Law (UNCITRAL) and supported by the National University of Singapore's Centre for International Law (CIL), the Sixth Intersessional Meeting of Working Group III will focus on the proposed standing multilateral mechanism and appellate mechanism for investor-State dispute settlement (ISDS).

The standing multilateral mechanism and appellate mechanism are two distinct, though overlapping, proposals. Of the range of reform elements being considered by Working Group III, it is these two reform elements that involve the most significant structural change to the ISDS landscape.

UNCITRAL members and observers have had the opportunity to discuss certain aspects of these two reform elements but have not had the opportunity to discuss them fully. Working papers, initial drafts and background material on the standing multilateral mechanism may be found here, and on the appellate mechanism, here.

This Sixth Intersessional Meeting will be an opportunity for UNCITRAL members and observers to delve deeper into the issues that will need to be considered in developing these reform options and canvass the range of considerations and perspectives on these issues.

As this is a not a formal Working Group III meeting, discussions and views expressed by UNCITRAL members and observers during the sessions and roundtable will be informal. During the sessions, kindly allow the moderators flexibility to decide on the speaking order. Preference will generally be given to UNCITRAL members and observers. The intersessional meeting will be recorded and made available subsequently to all UNCITRAL members and observers. Simultaneous interpretation between English and French will be provided.

Synopsis:

Developing tools for the avoidance of investor-State disputes is a priority for many States in UNCITRAL Working Group III. Among the many challenges faced by States in this respect is that the application of investment treaties often falls to officials who are either unaware or not equipped to take account of the State's treaty obligations. As a result, the State is exposed to increased risk of violating its international commitments and, in turn, potential negative impacts on the attractiveness of the State as a destination for investment.

Dispute avoidance is a whole-of-government concern. To address these challenges, States need practical tools. This side event will discuss key tools currently available to States to promote the prevention and avoidance of investor-State disputes, including the use of government handbooks designed to provide non-specialist officials with practical explanations of how investment treaty obligations apply to day-to-day government decision making.

Daphne Hong is concurrently the Solicitor-General of the Attorney-General's Chambers of Singapore and the Director-General of its International Affairs Division (IAD). She is Singapore's Legal Adviser and heads IAD, the department that advises the Singapore government on all international law matters and represents Singapore in international negotiations and dispute resolution. She has been involved in, *inter alia*, the applications to the ICJ for the revision and interpretation of its 2008 judgement concerning the sovereignty over Pedra Branca / Pulau Batu Puteh, Middle Rocks and South Ledge, and Singapore's intervention as Third Party in the WTO Dispute on Australia's Plain Packaging measure. She is also the lead negotiator for the delimitation of Singapore's maritime boundaries.



Shane SPELLISCY

Chairperson, UNCITRAL Working Group III Director General, Trade Law Bureau of Canada Deputy Legal Adviser, Global Affairs Canada

Shane Spelliscy is currently the Director General of the Trade Law Bureau of Canada and the Deputy Legal Adviser at Global Affairs Canada. As the Director General, he is the Government's most senior international trade lawyer, responsible for all international trade related legal advice. He joined the Trade Law Bureau in 2008. He has provided advice on Canada's obligations under its trade and investment treaties and served as counsel in trade and investment treaty negotiations and disputes. He has acted as Canada's delegate at UNCITRAL since 2008, including with respect to the revision of the UNCITRAL Arbitration Rules, the development of the UNCITRAL Rules on Transparency, and the negotiation of the Mauritius Convention on Transparency in Treaty-Based ISDS. In November 2017, he was elected by the Member States of UNCITRAL as the Chair of Working Group III, which has been tasked with considering possible reforms in the field of ISDS.

Anna Joubin-Bret is the Secretary of the United Nations Commission on International Trade Law and the Director of the International Trade Law Division in the Office of Legal Affairs of the United Nations. Prior to her appointment, Ms. Joubin-Bret practiced law in Paris, specializing in International Investment Law and Arbitration, as counsel and arbitrator. Prior to 2011, she was a Senior Legal Adviser with UNCTAD. She holds a DEA in Private International Law and a Master's Degree in International Economic Law from Paris I and a Bachelor Degree in Political Science.





Jae Sung LEE

Jae Sung Lee is a senior legal officer at the International Trade Law Division of the United Nations Office of Legal Affairs, which functions as the substantive secretariat for UNCITRAL. He currently functions as the secretary of Working Group III on Investor-State Dispute Settlement Reform and has served as secretary of working groups on dispute settlement, secured transactions and electronic commerce. Before joining the United Nations in 2007, Mr. Lee served in the Korean Ministry of Foreign Affairs. A Korean national, Mr. Lee is a graduate of Seoul National University College of Law, holds LL.M. degrees from Seoul National University Graduate School of International Studies and NYU School of Law as well as a Ph.D. in Law from Seoul National University.



Colin BROWN

Head of Unit, Legal Aspects of Trade and Sustainable Development and Investment, Directorate General for Trade, European Commission

Colin Brown is an international trade and investment lawyer. Since November 2020, he is Head of Unit, Legal Aspects of Trade and Sustainable Development and Investment, in the Directorate General for Trade of the European Commission. From 2013 to 2020 he was Deputy Head of Unit of Dispute Settlement and Legal Aspects of Trade Policy. He leads the team of lawyers working on investor-State dispute settlement in the trade and investment policy of the European Union, in particular the Investment Court System and now the work on the Multilateral Investment Court project. He is the head of the EU Delegation to UNCITRAL Working Group III on ISDS reform. He also leads the teams providing legal advice on EU FTAs and on Trade and Sustainable Development.

Before joining the Directorate General for Trade in October 2006 he worked for 6 years for the Legal Service of the European Commission, where he litigated WTO and EU law cases. He was Chair of the Legal Advisory Committee of the Energy Charter Treaty between 2004 and 2017. He is guest lecturer in EU External Economic Relations Law at the Law School of the University of Edinburgh and the Academy of Internal Economic Law and Policy (Athens). He has taught EU and WTO law at IELPO, University of Barcelona and the Université catholique de Louvain.

He holds an LLB (first class Honours) from the Faculty of Law of the University of Edinburgh, Scotland, a Diploma in International Relations from the Bologna Center of the School of Advanced International Studies (SAIS), Johns Hopkins University, Bologna, Italy and an LLM in European Law from the College of Europe, Bruges. He has UK and Belgian nationality.





Michael Imran KANU

Ambassador and Permanent Representative of Sierra Leone to the United Nations

Michael Imran Kanu currently serves as Ambassador and Permanent Representative of the Republic of Sierra Leone to the United Nations in New York. He is a member of the Legal and Technical Commission of the International Seabed Authority. Prior to his recent appointment as Permanent Representative, Ambassador Kanu served for 5 years as the Deputy Permanent Representative for Legal Affairs in the Permanent Mission of Sierra Leone and covered the Main Committees of the United Nations General Assembly including the Sixth (Legal) Committee, human rights in the Third Committee, treaty negotiations in the First Committee, Ocean and Law of the Sea issues, the International Seabed Authority and the International Criminal Court where he currently serves as co-chair of the Review Mechanism. In addition to other roles, he also coordinated the African Group in the negotiations leading to the conclusion of the Agreement on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction (BBNJ). He currently coordinates the African Group in New York on investor-State dispute settlement reform work being undertaken by the United Nations Commission for International Trade Law Working Group III.



Lauren MANDELL

Special Counsel, WilmerHale

Lauren Mandell is an international trade and investment attorney at WilmerHale in Washington. Mr. Mandell specializes in the negotiation of free trade agreements and bilateral investment treaties and the resolution of disputes arising under such agreements. Prior to joining WilmerHale, Mr. Mandell served for six years at the Office of the U.S. Trade Representative. There, Mr. Mandell was the U.S. government's lead negotiator of the investment chapter of the US-Mexico-Canada Agreement (USMCA) and lead counsel in the negotiation of the investment chapter of the Trans-Pacific Partnership (TPP). Mr. Mandell was also a U.S. delegate to Working Group III, beginning with the first meeting under the current mandate in November 2017. Since 2019, Mr. Mandell has represented the U.S. Council for International Business (USCIB) in Working Group III. The USCIB is an association of international companies, law firms, and business associations from every sector of the economy dedicated to promoting international trade and investment.



Taylor ST JOHN

Researcher, PluriCourts, University of Oslo

Taylor St John is a Lecturer at the University of St Andrews, currently on leave to co-direct the Compliance Politics of International Investment Disputes (COPIID) project at PluriCourts, University of Oslo. She researches the development and design of international institutions, especially institutions related to investment. Her book, The Rise of Investor-State Arbitration: Politics, Law, and Unintended Consequences, was published in 2018.
