**Operationalization of the Advisory Centre on  
International Investment Dispute Resolution**

**Annotated provisional agenda**

**I. Introduction**

1. In 2024, the United Nations Commission on International Trade Law (“UNCITRAL” or the “Commission”) finalized and adopted in principle the Statute of the Advisory Centre on International Investment Dispute Resolution (the “Advisory Centre”).<sup>1</sup> The Statute, which consists of 16 articles, sets forth rules on the creation of the Advisory Centre, its objectives, general principles of operation, membership, governance structure, services, financing, legal status and liability and other related issues.<sup>2</sup>
2. When adopting the Statute in principle, the Commission agreed that the operationalization of the Advisory Centre would require further preparatory work.<sup>3</sup>
3. The Commission agreed that the basis of the preparatory work should be the Statute and that the work could address issues such as: (a) ways to establish the Advisory Centre within the United Nations system based entirely on extrabudgetary resources; (b) criteria for determining the location of the headquarters and regional offices; (c) the anticipated budget based on potential membership and workload, and the need to ensure sustainable operations; (d) the amount of contributions by Members and methods of payment; (e) objective criteria for classifying States in the annexes; (f) thresholds of membership and contributions for the entry into force of the Statute; and (g) decisions, rules and regulations to be adopted by the Governing Committee, including staff and financial regulations.<sup>4</sup>
4. The Commission also agreed that in order to facilitate the preparatory work, it would utilize an informal process involving all States and regional economic integration organizations (REIOs). It was agreed that, as an informal process, no decisions should be made, and efforts should be made to maintain the transparency and inclusiveness of the process by ensuring remote participation and by making a summary of the discussions available.<sup>5</sup>
5. The first meeting on the operationalization of the Advisory Centre (“AC-OP meeting”) was held from 2 to 4 December 2024 in Bangkok, Thailand at Siam Kempinski Hotel.<sup>6</sup> At that meeting, the proposal by the Government of Armenia to host the second AC-OP Meeting in Yerevan from 6 to 8 May 2025 was welcomed.
6. The summary of the first AC-OP meeting was presented for discussion and exchange of view ([A/CN.9/1196](#), paras. 19-30) during the first part of the

fifty-first session of Working Group III (17-19 February 2025) without the Working Group taking any decisions on the summary.<sup>7</sup>

7. At that meeting, views diverged on whether the summary of the second AC-OP meeting should first be presented to the Working Group or could be presented directly to the Commission. In light of the divergence in views, it was agreed that the summary could be presented to the Commission at its upcoming session, where the Commission could further discuss whether the summaries of AC-OP meetings, would need to be presented to the Working Group every time for an exchange of views before the Commission takes any decision related to the possible outcomes of those meetings (A/CN.9/1196, para. 30).

8. The invitations to the second AC-OP Meeting were dispatched on 20 March 2025 to all Member States of the United Nations via note verbale to the permanent missions. Invitations were also sent to relevant inter-governmental organizations. Registration deadline for in-person is 19 April 2025. Information about the meeting is being updated on the [dedicated webpage](#).

## II. Agenda items

9. The second AC-OP meeting will be held at the Elite Plaza Business Center (Yerevan, Armenia) from 6 to 8 May 2025 (Tuesday to Thursday). Meeting hours will be from 9:30-12:30 and 14:00-17:00 (UTC+4), except on 6 May 2025 (Tuesday) when the meeting will begin at 10:00.

10. The meeting will be chaired by Mr. Shane Spelliscy and Ms. Natalie Yu-Lin Morris-Sharma.<sup>8</sup>

11. The meeting will continue to discuss matters pertaining to: (1) ways to establish the Advisory Centre within the United Nations system; (2) the location of the headquarters and regional offices; (3) classification of Members of the Advisory Centre; (4) budget and financing including the amount of contributions by Members and methods of payment; (5) thresholds of membership and contributions for the entry into force of the Statute.

13. The meeting will be held in hybrid format with interactive virtual participation available. Simultaneous interpretation between English and French will be provided. Partial travel support may be provided to limited number of participants from developing countries.<sup>9</sup>

#### **Background documentation**

14. The Commission requested the secretariat to provide support for the preparatory support work and the informal process, including the preparation of background documents.<sup>10</sup> Accordingly, the secretariat will prepare the following documentations to facilitate the discussions.

15. States and REIOs are encouraged to submit documents for consideration at the second AC-OP meeting. They will be made available on the dedicated webpage.

#### **Summary of the meeting**

16. The summary of the second AC-OP meeting will be presented to the Commission at its fifty-eighth session in 2025 as document A/CN.9/1218 (see para. 7 above). It will be presented along with the summary of the first AC-OP meeting ([A/CN.9/WG.III/WP.251](#)) and the report of the Working Group of its first part of the fifty-first session ([A/CN.9/1196](#)).

#### **Future AC-OP meetings**

17. The Government of France expressed its interest to host the third AC-OP meeting in Paris tentatively from 1 to 3 December 2025 ([A/CN.9/1196](#), para. 28). The Government of Paraguay also expressed an interest to host an AC-OP meeting in the near future. The secretariat will continue to consult with those Governments.<sup>11</sup>
