## Welcome Remarks



**Anna Joubin-Bret**  
Secretary of UNCITRAL

Ms. Anna Joubin-Bret is the Secretary of the United Nations Commission on International Trade Law (UNCITRAL) and the Director of the International Trade Law Division in the Office of Legal Affairs of the United Nations, which functions as the substantive secretariat for UNCITRAL. She is the ninth Secretary of the Commission since it was established by the General Assembly in 1966. Prior to her appointment on 24 November 2017, Ms. Joubin-Bret practiced law in Paris, specializing in International Investment Law and Investment Dispute Resolution. She focused on serving as counsel, arbitrator, mediator and conciliator in international investment disputes. She served as arbitrator in several ICSID, UNCITRAL and ICC disputes. Prior to 2011 and for 15 years, Ms. Joubin-Bret was the Senior Legal Adviser for the United Nations Conference on Trade and Development (UNCTAD). She edited and authored seminal research and publications on international investment law, notably the Sequels to UNCTAD IIA Series and co-edited with Jean Kalicki a book on Reform of Investor-State Dispute Settlement in 2015. Ms. Joubin-Bret holds a post-graduate degree (DEA) in Private International Law from the University of Paris I, Panthéon-Sorbonne, a Masters Degree in International Economic Law from University Paris I and in Political Science from Institut d'Etudes Politiques. She was Legal Counsel in the legal department of the Schneider Group, General Counsel of the KIS Group and Director-Export of Pomagalski S.A. She was appointed judge at the Commercial Court in Grenoble (France) and was elected Regional Counsellor of the Rhône-Alpes Region in 1998.

Ambassador, Permanent Representative of Kenya, Chairperson of  
the G-77 Vienna Chapter for 2025 (TBD)

Amb. Maurice Makoloo is the Ambassador of Kenya to Austria and Permanent Representative to the UNOV. Previously, Ambassador Makoloo chaired the Africa Group of Ambassadors, from August 2024 till 23rd January, 2025. Effective 4th February, 2025, Ambassador Makoloo has assumed the Chairmanship of the G-77 Vienna Chapter. Prior to his appointment as Ambassador, he served as the Vice President for the Africa Area Office- Habitat for Humanity International. He joined Habitat on 1st February 2021 with over 20 years' experience as a strategic global nonprofit executive leader who had developed and led successful organizations in Africa. As Africa Area Vice President, Amb. Makoloo led the development and execution of a regional strategy to support the Habitat's Global Impact 2025(GI-25) goal of tripling Habitat's impact. He also provided representation with key donor, government, and development partners in Africa. For nine years prior to Habitat for Humanity International, he served as the East Africa Regional Director for the Ford Foundation. Amb. Maurice holds Bachelors and Master's degrees in law from the University of Nairobi. He is a PhD candidate at the University of the Witwatersrand, South Africa. He is also a certified Leadership Coach (Georgetown University, USA). He also served in several boards including the International Board of the Voluntary Services Overseas (VSO)- London; the MicroBuild Fund Board (Atlanta-USA); the University of Nairobi Foundation; PS Kenya; Habitat for Humanity Boards in Kenya, Zambia, Malawi and South Africa respectively among others.



## *Session 1. Understanding Negotiable Cargo Documents*



**Beate Czerwenka**  
Chair of UNCITRAL Working Group VI  
(Negotiable Cargo Documents)

Prof. Dr. Czerwenka has been working for more than 36 years in the German Federal Ministry of Justice. As head of the division “Commercial Transactions, Transport Law” she was responsible for a comprehensive reform of German transport law in 1998 and of German maritime law in 2013. Also, she was involved in numerous international negotiations on commercial law matters. As such, she negotiated – amongst others - the UN Convention on Contracts for the International Carriage of Goods Wholly or Partly by Sea, the so-called Rotterdam Rules, the Budapest Convention on the Contract for the Carriage of Goods by Inland Waterways (CMNI), the revision of the Uniform Rules concerning the Contract of International Carriage of Goods by Rail (CIM) and the Additional Protocol to the Convention on the Contract for the International Carriage of Goods by Road (CMR) concerning the electronic consignment note. Most recently she has chaired the UNCITRAL Working Group VI, which elaborated the draft convention on the international effects of judicial sales of ships as well as the draft convention on negotiable cargo documents.

Prof. Czerwenka has published widely in the field of trade law, in particular transport and maritime law, and is co-editor of the journals “Transportrecht” (Transport Law) and “Internationales Handelsrecht” (International Commercial Law). Moreover, she teaches at Humboldt University, Berlin.





**Yanying Li**  
Legal Officer, UNCITRAL Secretariat

Yanying Li is a legal officer at the International Trade Law Division (ITLD), Office of Legal Affairs of the United Nations, which serves as the secretariat to the United Nations Commission on International Trade Law. Since 2019, Yanying has been involved in the exploratory and preparatory work for the development of a legal instrument on negotiable cargo documents. The project was assigned to UNCITRAL Working Group VI in 2022. Currently, Yanying is the Secretary of UNCITRAL Working Group VI (Negotiable Cargo Documents) and also supports the organization of the annual sessions of the Commission.

Before joining the ITLD, she worked in the field of banking and international arbitration at the Asian Development Bank (Manila), Clifford Chance LLP (London) and the Permanent Court of Arbitration (the Hague).
