UNCITRAL AP Day 2023

The UNCITRAL Asia Pacific Days is an annual flagship academic series launched in 2014 by the United Nations Commission on International Trade Law Regional Centre for Asia and the Pacific ("UNCITRAL RCAP") to commemorate the December 1966 General Assembly resolution establishing UNCITRAL. The AP Days aim at raising awareness of UNCITRAL's texts and the importance of legal harmonisation amongst law students – the next generation of legal thinkers and policymakers – and are thus academic in nature and free of admission charges.

The suggested theme for AP Days 2023 is "Exploring the digital frontiers of cross-border trade". Digital technologies have impacted all aspects of everyday life, including cross-border trade. However, there may also be challenges in the use of transferable documents in electronic form. Moreover, electronic exchanges are not only about information sharing, but also about data analysis and reuse, and this has given rise to a new set of issues with regard to data provision.

Academic activities in this series aim to raise awareness of these issues and educate on the importance of legal harmonisation through UNCITRAL texts to solve and/or reduce them. UNCITRAL has prepared a legal framework for the digital economy that enables and facilitates the use of electronic means to engage in commercial activities. Further, the origining legislative work at UNCITRAL is focused on legal aspects of the use of automation in contracting, including artificial intelligence, and of data contracts. The proposed theme provides a timely discussion on how UNCITRAL's existing framework on e-commerce and ongoing legislative work could support States in developing an enabling legal framework for cross-border trade in the digital economy, noting that the work of UNCITRAL on digital trade law does not deal with regulatory issues such as consumer protection and data privacy and protection.

This year, 32 universities and institutions across the Asia-Pacific region in 11 jurisdictions have joined the AP Days 2023 by co-hosting a series of academic events with UNCITRAL RCAP to promote awareness of international trade standards and norms, particularly those endorsed by UNCITRAL, amongst law students — the next generation of legal thinkers and policymakers.
