

Orkun Akseli Professor of Commercial Law, Academic Director, Manchester LawTech Initiative, Law School, University of Manchester (Manchester, UK): Secured Transactions Law Reform and Digital Assets

Professor Orkun Akseli is Professor of Commercial Law at the University of Manchester Law School. He was the Academic Director of Manchester LawTech Initiative between 2022-2024. Previously, he taught at the Robert Gordon University, Newcastle University and Durham University. He was a Fulbright Scholar at Elon University Law School, USA in 2022 where he taught secured transactions, and international business transactions. He has published extensively on the modernisation and harmonisation of secured transactions law. His research has focused on the laws relating to secured credit, and the social and economic impact of these laws with reference to the financing of SMEs. He frequently engages with national policy making and international formulating organisations. His publications include "Secured Transactions in Global Law-making" (under contract with Hart, co-authored with S.V. Bazinas); "The Use of ADR in the Enforcement of Security Interests and Insolvency" (under contract with Brill, co-authored and edited with Teresa Rodriguez de las Heras Ballell); "The Future of Commercial Law: Ways forward for Change and Reform" (Hart 2020, with J. Linarelli); "International and Comparative Secured Transactions Law" (Hart 2017, with S.V. Bazinas); "Secured Transactions Law Reform: Principles, Policies and Practice" (Hart 2016, with L. Gullifer); "Availability of Credit and Secured Transactions in a Time of Crisis" (CUP 2013); "International Secured Transactions Law: Facilitation of Credit and International Conventions and Instruments" (Routledge 2011). He studied law in Turkey (LLB Dokuz Eylul University, MA Istanbul Bilgi University), USA (LLM University of Georgia) and the UK (PhD University of Manchester). He is an Associate Member of the International Academy of Comparative Law, and the past President, and current Secretary General of the International Academy of Commercial and Consumer Law. He is a member of Turkish Bar.



Mehmet Mücahit Arvas Founder Marvas Legal

Mehmet Mücahit Arvas is the founder of Marvas Legal law firm in Ankara and currently works as a part-time lecturer at TED University. He has 17-years' public sector experience such as trade expert, head of department and commercial counsellor at the Ministry of Trade. In 2016, he was appointed as a manager of Modern Secured Transaction Reform Project. He prepared and drafted the Law on Movable Collateral in Commercial Transactions and took part in the establishment of the movable collateral registry. In 2017, he was appointed as the Head of the Department of Electronic Commerce and Secured Transactions. He also served as the focal point for Turkey in the 'Getting Credit' section of the World Bank's Doing Business project. He managed the Electronic Trade Trust Stamp, Electronic Trade Information System (ETBIS) and Electronic Trade Information Platform projects in order to create data-oriented electronic trade policies. He also carried out an awareness project with the solidarity campaign 'As e-commerce, we stand by SMEs' during the pandemic process. He holds Master degree from Bournemouth University and in PhD degree from Ankara University on modern secured transactions law.



Yvonne Atwiine Mwesige Senior Legal Officer Uganda Registration Services Bureau (URSB)

Yvonne Atwiine Mwesige is a senior legal officer at the Uganda Registration Services Bureau (URSB), specializing in secured transactions law and financial inclusion.

She played a pivotal role in transitioning Uganda from the Chattel Transfers Act Cap 70 (a 1975 law) and the Chattels Securities Act of 2014 to the Security Interest in Movable Property Act (SIMPA), Cap 293.

She was actively involved in the research and drafting of this law to ensure its alignment with international best practices for modern collateral registries.

She was also part of the Implementation Team that established the Security Interest in Movable Property Registry System (SIMPO), which was successfully r olled out in September 2019 and a pioneer staff of URSB's Collateral Registry Unit, ensuring its successful operationalization.

Yvonne has extensive experience in commercial law, company law, oil and gas law, and access to credit frameworks, having worked for over 12 years in Uganda's legal sector, including 10 years at URSB. She has collaborated with the World Bank's International Finance Corporation (IFC) and Financial Sector Deepening Uganda (FSDU) on financial sector reforms and has worked with legal experts across Ghana, Malawi, Ethiopia, Zambia, and Zimbabwe to enhance secured transactions frameworks.

Recently, Yvonne spearheaded the integration of Uganda's Motor Vehicle Registry with SIMPO, leading to a significant increase in the uptake of security interests in motor vehicles and improving the registry's visibility among lenders and the public.

She holds a Master of Laws from Uganda Christian University, a certification in Comparative Secured Transactions Law from the Central European University, a Post Graduate Diploma in Legal Practice, and a Bachelor of Laws from Makerere University.




Spyridon V. Bazinas Consultant and Lecturer

Mr. Bazinas is a Visiting Professor at the Law School of the University of Athens and Thessaloniki, Greece, and Vienna, Austria, an author and an independent consultant advising States and national and international organizations on trade law reform matters. From 1989 to 2017, he served with the United Nations Secretariat, Office of Legal Affairs, first with the General Legal Division in New York (1989-1992) and then with the International Trade Law Division (United Nations Commission on International Trade Law ("UNCITRAL") Secretariat) in Vienna (1992-2017). He was the Secretary of the UNCITRAL Working Group VI (Security Interests) from 2003 to 2017, when it prepared the Guide to Enactment of the UNCITRAL Model Law on Secured Transactions (2017), the UNCITRAL Model Law on Secured Transactions (2016), the UNCITRAL Guide on the Implementation of a Security Rights Registry (2013), the Supplement on Security Interests in Intellectual Property Rights (2010), and the UNCITRAL Legislative Guide on Secured Transactions (2007). He also served as Secretary of the Working Group on International Contract Practices, when it prepared the Convention on the Assignment of Receivables in International Trade (2001). He was also involved in the Commission's work on insolvency, bank guarantees, procurement and electronic commerce. He also provided technical assistance to States and lectured all over the world on a variety of international trade law topics. Mr. Bazinas co-authored more than ten books and published more than fifty articles on various topics and, in particular, on secured financing and insolvency.



Maria del Pilar is a lawyer with master's and doctoral studies. She has more than 20 years of experience in corporate law, mergers and acquisitions and secured transactions. She is an international consultant expert on secured transactions, leasing, factoring and insolvency, she has worked for different organizations in different jurisdictions, especially in Latin America. She is a professor at the Francisco Marroquin University of civil contracts and commercial contracts, and has also given lectures and courses in different countries. She has participated in working groups at Uncitral and Unidroit.



William Brydie-Watson Senior Legal Officer International Institute for the Unification of Private Law (UNIDROIT)

William Brydie-Watson is a Senior Legal Officer at the International Institute for the Unification of Private Law (UNIDROIT), based in Rome. William specialises in international instruments related to access to credit and secured transactions law. He has primary responsibility for the development of the UNIDROIT Model Law on Factoring and the implementation of the Cape Town Convention on International Interests in Mobile Assets and its Protocol on mining, agricultural and construction equipment (the 'MAC Protocol'). William is also Co-Director of the UNIDROIT Asian Transnational Law Centre, the manager of the UNIDROIT Scholarship, Internship and Research Programme and an advisor to the UNIDROIT Foundation. In 2024 William was also appointed to the Board of Directors of the International Law Institute, in Washington DC.

Previously, he was a Legal Officer in the Private International Law section of the Australian Commonwealth Attorney-General's Department and worked on the implementation of private international law treaties in Australia. William is a visiting lecturer at the Eötvös Loránd University in Budapest, Hungary. Admitted to practice law by the Supreme Court of New South Wales, William has a Bachelor of Arts, a Bachelor of Laws (Honours) and a Master of Laws from the Australian National University.



Giuliano G. Castellano Associate Professor of Law Deputy Director Asian Institute of International Financial Law Faculty of Law University of Hong Kong

Giuliano is an Associate Professor and a Deputy Director of the Asian Institute of International Financial Law at the Faculty of Law of the University of Hong Kong (HKU). He has over 15 years of experience in international and comparative financial law, focusing on digital technologies, regulation, and law reforms to promote access to credit. He holds a Law Degree (Bocconi University), a Ph.D. in Economics and Social Sciences (Ecole Polytechnique), and a Ph.D. in Comparative Law (University of Turin). Before joining HKU, he was an Associate Professor at the University of Warwick; prior to that, he was a Fellow at the LSE Law Department.

Beyond academia, Giuliano has been influencing international and domestic policymaking. Since 2010, he has contributed to drafting international instruments adopted by the U.N. Commission of International Trade Law (UNCITRAL) and the Institute for the Unification of Private Law (UNIDROIT), including the UNCITRAL Model Law on Secured Transactions and the UNIDROIT Model Law on Factoring. He regularly cooperates with the International Finance Corporation (IFC) of the World Bank and the European Bank for Reconstruction and Development (EBRD) to define global policies on the regulatory treatment of digital assets in the context of secured transactions, supply-chain finance, and MSME lending. In this role, he advised governments, central banks, and regulators of over 20 jurisdictions on law reforms supporting sustainable access to credit, financial stability, and market integrity.



Ipshita Chaturvedi Legal Consultant, International Law Chambers: Regulatory bottlenecks on VCCs as collateral in secured transactions

Ipshita Chaturvedi is an environmental lawyer with over 16 years of experience in sustainability, conservation and the carbon markets. She has advised governments, international organizations, think tanks and the private sector on issues of biodiversity law, water, climate finance and transactional risks in carbon investments.



Neil B. Cohen Jeffrey D. Forchelli Professor of Law Brooklyn Law School (New York, USA)

Neil B. Cohen, 1901 Distinguished Research Professor of Law at Brooklyn Law School, has been a key participant in major domestic and international law reform projects with respect to commercial transactions for over three decades. In the United States, he has served as Reporter for Revised Article 1 of the Uniform Commercial Code and for the American Law Institute's Restatement of the Law of Suretyship and Guaranty; in honor of his accomplishments as Reporter for the Restatement, he was named as the Institute's R. Ammi Cutter Reporter. Professor Cohen also was the U.S. Reporter for the recently promulgated Principles of Law for the Data Economy, a joint project of the American Law Institute and the European Law Institute. He has served as Director of Research of the Permanent Editorial Board for the Uniform Commercial Code since 1998. Internationally, Professor Cohen has long experience in the modernization and harmonization of commercial law. He has served as a member of United States delegation to the United Nations Commission on International Trade Law for its work on harmonizing and modernizing the law of secured credit, as a member of the Working Group at the Hague Conference on Private International Law that prepared its Principles on Choice of Law in International Commercial Contracts, and as a Working Group member for the work of UNIDROIT in its development of principles for international contracts and for enforcement of claims and for its current project to develop a Model Law on Factoring. Since 2009, he has been a member of the United States Department of State's Advisory Committee on Private International Law. Professor Cohen is a co-author of Farnsworth, Sanger, Cohen, Brooks and Garvin, Contracts: Cases and Materials and of Twerski and Cohen, Choice of Law: Cases and Materials for a Concise Course on Conflict of Laws as well as dozens of other books and articles concerning domestic and international commercial law. Professor Cohen received an S.B. from the Massachusetts Institute of Technology and a J.D. from New York University School of Law, where he was a Root-Tilden Scholar.






Dr. Marek Dubovec is the Director of Law Reform Programs at the International Law Institute (ILI) and Part-Time Professor of Practice at the University of Arizona, James E. Rogers College of Law. For over 15 years, Marek has been working with international standard-setters, especially UNCITRAL and UNIDROIT, to draft conventions, model laws, principles, and guides that assist States in modernizing their commercial law frameworks. He has worked on implementing these standards under projects funded by the World Bank Group, the EBRD, FSD-Kenya, and others. He has assisted countries in Africa (e.g., Kenya), Asia (e.g., the Philippines), Eastern Europe (e.g., Ukraine), the Middle East (e.g., the UAE) and Latin America (e.g., Colombia) with reforms of their frameworks on secured transactions, factoring, warehouse receipts, and related legislation. In these projects, Marek advised on the drafting of laws/regulations and technological infrastructures, including collateral registries, and provided capacity building to various stakeholders, including financial institutions, government officials, and judges.

Marek is one of the principal authors of policy papers, reports, and other publications for international organizations, including the Secured Transactions, Collateral Registries, and Movable Asset-Based Financing Knowledge Guide, and Guidance Notes on Distributed Ledger Technology and Secured Transactions for the World Bank Group, and the New Finance Support Report for the EBRD. He has authored and co-authored numerous articles and books, including the 2019 Secured Transactions Law Reform in Africa. Marek is an elected member of the American Law Institute.



Belinda Ellington Senior Advisor, International Emissions Trade Association (IETA): VCC market infrastructure and oversight

Belinda is a senior legal professional with more than 25 years' experience in law, regulation, policy and negotiation relating to Banking, Trading and Finance across Global Commodities' Markets and Sustainable Finance. She recently left Citi Bank, where she was MD and head of legal for commodities and sustainable finance, to focus on driving finance towards the goals of the Paris Agreement and conduct mediated negotiation and dispute resolution. One of her roles is as senior advisor to the International Emissions Trade Association, where she is intent on identify and resolving legal barriers and challenges across carbon markets and support development of effective carbon markets through capacity building. Belinda represents IETA on the UNIDROIT drafting committee developing the principles for classification of verified carbon credits under private law and supports the legal working group.



Henry Gabriel is a Professor of Law at Elon University. He served four terms as a member of the UNIDROIT Governing Council, and for the last twenty-five years has been a United States delegate to the UNCITRAL Working Group on Electronic Commerce. He is an Elected and Life Member of the American Law Institute, a Fellow of the European Law Institute, and a Commissioner and Life Member of the American Uniform Law Commission



Mary Gilmore-Maurer Senior Legal Counsel - Legal, Risk and Governance Department

Mary Gilmore-Maurer (PhD) is a qualified lawyer in the UK with extensive experience in practice and academia. She now works as Senior Legal Counsel at Verra, one of the world's leading carbon registries and standards for climate action and sustainable development. Before joining Verra in 2022, Mary specialized in commercial, energy and environmental law, working in the energy and utilities sector and as a lecturer at the University of Aberdeen, where she obtained her PhD in law. At Verra, Mary advises across the organization on legal and regulatory matters, including the application and enforcement of Verra's program rules, strategic agreements and the Verra Registry Terms of Use, in addition to requirements under the CORSIA and ICVCM frameworks. Mary represents Verra in the UNIDROIT Working Group on the Legal Nature of Carbon Credits.



Gérardine Goh Escolar Deputy Secretary General, Hague Conference on Private International Law (HCCH)

Dr Gérardine Goh Escolar is Deputy Secretary General of the Permanent Bureau of the Hague Conference on Private International Law (HCCH). Concurrently, she is Head of the International Commercial, Digital and Financial Law (CODIFI) Division which includes, among other portfolios, responsibility over the HCCH 2006 Intermediated Securities Convention, the 2015 HCCH Principles on the Choice of Law in International Commercial Contracts, the Experts' Group on Central Bank Digital Currencies (CBDCs), the study on Digital Tokens, and the monitoring of private international law developments in the digital economy, voluntary carbon markets, restructuring and insolvency, and intellectual property. Dr Goh Escolar is Professor (Adj) at the Faculty of Law, and Academic Fellow at the Centre for Technology, Robotics, Artificial Intelligence and the Law (TRAIL), both of the National University of Singapore.



Yaochen Gong Associate Legal Officer Treaty Section United Nations Office of Legal Affairs

Yaochen GONG recently joined the Treaty Section of the United Nations Office of Legal Affairs as an Associate Legal Officer. Before that, he worked for the International Trade Law Division of the same Office, which also serves as the secretariat of UNCITRAL. He was in charge of issues related to the UNCITRAL Transparency Standards and technical assistance for China. He also serviced the legislative work of UNCITRAL, including Working Group VI (Negotiable Cargo Documents) and the work programme on climate change and the law of international trade.

Before taking his current position in the UN, he worked for the Ministry of Commerce of China (MOFCOM) for 5 years, mainly focusing on WTO disputes settlement and modernization of trade policies in China. Megumi Hara is a professor at the Law School of Chuo University in Tokyo. She teaches property, contract, secured transaction, and trust law. She has published numerous articles on secured transaction law, property law, and other topics concerning civil law. Before joining Chuo University, she was appointed an associate professor at Kyushu University and then a professor at Gakushuin University. She has also taught courses at the University of Tokyo and Keio University.

She participated in the recent reforms of property law in Japan as a researcher appointed by the Ministry of Justice. Additionally, she served as a committee member for the Torihiki Hōsei Kenkyūkai (Research Group on Business Law), which collaborates with the Small and Medium Enterprise Agency under the Ministry of Economy, Trade and Industry (METI) in the preparatory efforts for amending secured transaction law in Japan.

She served as a delegate of Japan for the Diplomatic Conference for the adoption of the draft Protocol to the Convention on International Interests in Mobile Equipment on Matters specific to Agricultural, Construction and Mining Equipment (MAC Protocol). She has also participated as either a delegate for Japan or as an observer for UNCITRAL Working Group VI on Secured Transactions Reform. She represents Japan for UNCITRAL Working Group I deliberations on access to credit. She is also a member of the Model Law on Factoring working group and the Verified Carbon Credit Working Group for UNIDROIT.



WooJung Jon Assistant Professor, Korea Advanced Institute of Science and Technology (Daejeon, Republic of Korea)

WooJung Jon is Assistant Professor at the Korea Advanced Institute of Science and Technology (KAIST), where he specializes in legal and regulatory aspects of digital assets, blockchain, and intellectual property. He holds a Doctor of Philosophy (Ph.D.) in Law from the University of Oxford and has undertaken extensive research on security interests and their application to digital assets, culminating in both scholarly publications and policy-oriented projects. His recent work includes a principal investigator role in the government-sponsored research project "Comparative Analysis of Digital Asset Regulatory Landscape" (2023–2024), commissioned by the Korea Exchange (KRX), which offers a thorough examination of evolving digital-asset regulations and market practices in South Korea.

In addition to academic research, Professor Jon is actively shaping policy and legal frameworks through his positions on national committees. He currently serves on the Legal Advisory Group of the Busan Blockchain Regulation-Free Special Zone (November 2023–present) and the IT Blockchain Special Committee of the Korean Bar Association (September 2023–present). These roles build upon his broader efforts to promote robust, transparent regulation of digital asset markets, exemplified by his prior scholarly contributions. Notable among these are his analyses of the securities nature of virtual assets – particularly regarding the Terra-Luna incident – and the taxation of non-fungible tokens (NFTs) under Korean tax laws. Further reflecting his engagement with legal praxis, Jon's article advocating for a "clear and transparent digital asset market" highlights potential reforms to strengthen investor protection and market integrity.

Professor Jon is also a contributing author to the forthcoming Oxford Handbook of Digital Assets and the Law (Oxford University Press, 2025), co-authoring the "South Korea" chapter. His policy-oriented insights have been sought in international forums. Beyond academia, he brings extensive professional experience as a qualified lawyer (South Korea), a patent attorney, and a tax lawyer, with prior practice at Jeong Yul LLC focusing on foreign direct investment, multinational corporate transactions, and cross-border disputes.

This multifaceted background—encompassing legal scholarship, governmental advisory roles, and hands-on legal practice—positions Professor Jon at the forefront of digital asset governance research and reform efforts in South Korea and beyond.




Anna Joubin-Bret Secretary of the United Nations Commission on International Trade Law (UNCITRAL) Director of the International Trade Law Division in the Office of Legal Affairs of the United Nations

Ms. Anna Joubin-Bret is the Secretary of the United Nations Commission on International Trade Law (UNCITRAL) and the Director of the International Trade Law Division in the Office of Legal Affairs of the United Nations, which functions as the substantive secretariat for UNCITRAL. She is the ninth Secretary of the Commission since it was established by the General Assembly in 1966.

Prior to her appointment on 24 November 2017, Ms. Joubin-Bret practiced law in Paris, specializing in International Investment Law and Investment Dispute Resolution. She focused on serving as counsel, arbitrator, mediator and conciliator in international investment disputes. She served as arbitrator in several ICSID, UNCITRAL and ICC disputes. Prior to 2011 and for 15 years, Ms. Joubin-Bret was the Senior Legal Adviser for the United Nations Conference on Trade and Development (UNCTAD). She edited and authored seminal research and publications on international investment law, notably the Sequels to UNCTAD IIA Series and co-edited with Jean Kalicki a book on Reform of Investor-State Dispute Settlement in 2015.

Ms. Joubin-Bret holds a post-graduate degree (DEA) in Private International Law from the University of Paris I, Panthéon-Sorbonne, a Masters Degree in International Economic Law from University Paris I and in Political Science from Institut d'Etudes Politiques. She was Legal Counsel in the legal department of the Schneider Group, General Counsel of the KIS Group and Director-Export of Pomagalski S.A. She was appointed judge at the Commercial Court in Grenoble (France) and was elected Regional Counsellor of the Rhône-Alpes Region in 1998.




Richard Kohn Founder, and a Principal of the Commercial Finance Group, Goldberg Kohn Ltd

Richard M. He also teaches cross-border lending at The University of Chicago Law School. Richard was a member of the Expert Group for the UNCTRAL Legislative Guide on Secured Transactions (2007) (for which he also served as a co-editor), the related Supplement on Security Rights in Intellectual Property (2010), the Guide on the Implementation of a Security Rights Registry (2014), the Model Law on Secured Transactions (2016) and the related Guide to Enactment (2017), and the Practice Guide to the Model Law on Secured Transactions (2019), and is currently working on a best practices guide on enforcement for the International Institute for the Unification of Private Law (UNIDROIT). From 2001 to 2020, Richard served as Co-General Counsel of the Secured Finance Network (SFNet), the principal U.S. trade association for asset-based lenders. He is a Fellow of the American College of Commercial Finance Lawyers. He received both his B.A. and J.D degrees from The University of Michigan.

Jae Sung Lee is a senior legal officer at the International Trade Law Division of the United Nations Office of Legal Affairs, which functions as the substantive secretariat for UNCITRAL. He currently functions as the secretary of Working Group III on Investor-State Dispute Settlement Reform and has served as secretary of working groups on dispute settlement, secured transactions and electronic commerce. Before joining the United Nations in 2007, Jae Sung served in the Korean Ministry of Foreign Affairs. Jae Sung is a graduate of Seoul National University College of Law, holds LL.M. degrees from Seoul National University Graduate School of International Studies and NYU School of Law as well as a Ph.D. in Law from Seoul National University.

Shaun Leong, FCIArb, is an international arbitration specialist with more than sixteen years of experience in complex cross border disputes.
